BOOKING TERMS AND CONDITIONS

30 August 2011

Deposit & Payments:

- A deposit of 30% is payable to confirm your booking dates
- The second payment of 30% is payable 180 days prior to the booking date
- The balance of 40% is payable 120 days prior to the booking date

Payment of the initial deposit indicates acceptance of these booking terms and conditions.
All Credit Card payments (MasterCard & Visa only) will incur an additional 2% fee

Cancellation Fees:

Due to the nature of Weddings being pre-booked well in advance and the extreme difficulty to replace these bookings at short notice the following cancellation fees apply:

Total Booking Value – This is the total booking value of all amounts due by the bridal couple including the value of their guest accommodation.

- Bookings cancelled over 180 days prior to the wedding date will incur a cancellation fee of 30% of the total booking value.
- Bookings cancelled between 180 – 120 days prior to the wedding date will incur a cancellation fee of 60% of the total booking value.
- The client is not entitled to a refund if your booking is cancelled 120 days prior to your booked date.
- Date changes are not allowed 120 days prior to the wedding date. In this case the booking cannot be refunded if a client wishes to change the date.

Conditions:

The person affecting a booking shall be deemed to have accepted the booking conditions on behalf of all persons named on the booking form.

Care is taken to ensure that the description of the facilities and services is accurate. KVBR cannot be held liable for omissions or errors whether temporary or permanent of the properties facilities & services. Clients are welcome to do a pre property inspection by appointment.

KVBR can sometimes include 3rd party services at the retreat. As an agent on behalf of this service, KVBR will not be liable under any circumstances for any failure by those service providers to fulfill their arrangements. Payment for these services will be made directly by the client to the individual or business.

KVBR is not liable for events/circumstances beyond our control such as weather related issues and acts of nature effecting the energy supply.

Check in time is 2pm on the day of arrival. Check out time is 10am weekdays and 2pm Sundays. Late check-out is subject to availability & may incur a fee.

If you elect to choose Wedding Package 1 (Manning Package), the bridal party will be required to coordinate the cabin & lodge accommodation process which includes allocating all rooms to their guests. Kangaroo Valley Bush Retreat (KVBR) does accept payment from the wedding guests on a per cabin and lodge basis. The Bridal party is aware that they will underwrite the rental shortfall of all the cabins and lodge for the wedding at rates indicated in our advertising brochure. Guest's payment are required 2 months prior to the wedding.

We have seating and crockery for 90 guests. Any additional requirements such as crockery, marquee hire, additional cooler rooms and additional furniture will be for your account.

A complimentary night's stay for the bridal couple can be arranged prior to the wedding. We would appreciate if the night is booked on a weekday as weekends are now mostly fully booked. This night can be booked in advance, however we have the right to change this booking with a 5 day notice period. As we are an exclusive use venue, actual bookings will take preference over complimentary nights.

KVBR has the option to request a security deposit bond for large groups using the venue. This amount may be pre-determined prior to your arrival.

We supply all bedding, linen and towels to the rooms. Beds are not made up but you can request this to be undertaken at a nominal cost.

Guests are requested not to move furniture or bedding, as this may require an additional charge upon departure. The general rule is to please leave the property as you found it.

Outdoor Fire pit

Due to the nature & danger of an open fire at the "Outdoor Fire pit", please be aware of the following. There are only specific times that's this can be used and you will need to confirm this with the Manager. It is imperative that a responsible person from your party is assigned and briefed prior to the use. That person needs to sign an indemnity form and will also be responsible for control of the fire and its eventual termination.

Industrial Kitchen - Use & Policy

If you elect to use our onsite Caterer, this policy does not apply.

If you decide to either self cater or employ an external Caterer, then you will have access to all the kitchen equipment but you need to supply your own cooking utensils, cookware, cutlery, crockery and glassware.

Further to this, the caterer/individual shall be required to pay a fee of \$500 for the use of the kitchen and lodge a security deposit of \$500 prior to the event. The security deposit will be repaid within 7 days after a final inspection. The inspection will ensure that there is no damage to the kitchen equipment. In some instances either or both these fees may be waived.

All Catering companies are to collect their equipment from the property the day after the wedding. The kitchen is to be cleaned to a reasonable state, but all external caterers & self catering bookings will be subject to a final cleaning fee of \$150.

Prices:

All prices are subject to availability and can be withdrawn or varied without notice, unless a prior confirmed booking has been being made and the deposit paid.

Prices are subject to change if a booking is made over a year in advance, in line with new applicable rates at the time.
